What is Hope for Cats?

Hope for Cats is a 501(c)(3) non-profit, wholly volunteer organization. We have NO paid employees and all donations go directly to the care of our residents and foster cats. Hope for Cats operates Jake's Place - a cage free, no-kill shelter and adoption center. There is no limit to the length of time a cat can stay at Jake's Place. Admissions are limited only to control overcrowding. Hope for Cats receives no federal or state funding and is wholly dependent upon fundraising activities, foundation grants, and private donations to support its work. All of our cats are special, and we strive to provide excellent veterinary care and a home-like environment for each of them.

<u>Pierre</u>: Pierre was surrendered because, after his family had a new baby, he had trouble using the litterbox. The family tried a variety of solutions to ease his stress, but none worked long term. At Jake's Place, he used the



litterbox fine, and he was adopted by someone who knew his history but was willing to give him a chance. He has used the litterbox in his new home and his new person says that he is "the best cat ever". Pierre enjoys life

and lots of love. His person not only had a new "catio" built for him, but also, in honor of his name, she has taken up French classes, resuming a high school interest!

Continuation of Universal Charitable Deduction:

Individuals who elect to take the standard deduction can claim a deduction of up to \$300 for cash contributions made to certain qualifying charities during 2021, including Hope for Cats, Inc. The maximum deduction is increased to \$600 for married individuals filing joint returns.

You can sign up to feed, clean, scoop litter, or do health checks and give medications to any cats who are on meds. Even one hour per week will be a great help. Your donation will help us continue to provide shelter and care for cats in need. All of our cats are spayed/neutered, vaccinated and treated for internal and external parasites. Ongoing veterinary care is provided, including specialized diagnostics and treatments for cats requiring it.

<u>Rabies Vaccines</u>: Remember to keep your pets' rabies vaccines up to date. Even if your pets are always indoors, there can be risk of exposure, so it is best to be proactive.

another blind cat.

The Irving Cats: A family in Irving contacted us because they realized that they had too many cats. With the best intentions they had taken in a couple of



cats to get them out



of harm's way, but since they were not sterilized, their number grew to 14. Hope for Cats transported the 14 cats a few at a time; they were all spayed/neutered, vaccinated, etc.

Three were returned to their owners, and Hope for Cats took in 11, six of whom have been adopted and 5 of whom are ready for adoption.
